It is proposed to fill up the post of Research Analyst in International Relations/Regional Trade or Economics, at the Indian Ocean Rim Association (IORA) Secretariat, Port Louis, Mauritius on secondment basis initially for a period of two years and extendable depending upon the requirement of IORA Secretariat. The post will be at Deputy Secretary Level in the Ministry of External Affairs (Headquarters), New Delhi and the officer selected would be seconded to IORA Secretariat based in Port Louis, Mauritius as Research Analyst.

The mandatory and desirable qualifications for the postare as under:-

### **Mandatory Qualifications**

The officer must have worked for at least two years at the Centre under the Central Staffing Scheme.

The officer should be clear from vigilance angle.

The officer should not have been debarred from central deputation.

- x. The officer should have experience in International Trade and Regional Cooperation.
- xi. The officer should have conducted research analysis in International Trade & Commerce.

- b. Knowledge of Foreign Language.
