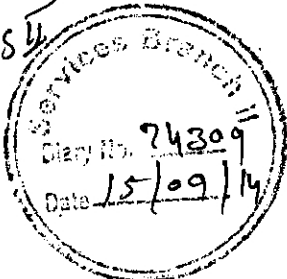

1. **PROFILE OF CENTRAL SOCIAL WELFARE BOARD** : The Central Social Welfare Board (CSWB) is a national apex organization working under this Ministry. The Board is implementing various welfare and developmental schemes intended for the development of women and children throughout the country. The Board has linkage with 33 State Social Welfare Boards situated in capitals of States and Union Territories and is supporting large number of voluntary organizations. As a national apex organization, CSWB strive to be recognized as the most progressive entity for providing services of unequivocal excellence to women and children for their protection, capacity building and total empowerment.

2. **JOB DESCRIPTION AND RESPONSIBILITIES OF EXECUTIVE DIRECTOR, CENTRAL SOCIAL WELFARE BOARD:** The Executive Director shall be responsible for general administration and to carry out the responsibility and functions of the CSWB and also to regularly monitor the schemes/projects in physical and financial terms being implemented by CSWB in accordance with the prescribed rules and the existing provisions in the Memorandum of Association and Articles of Association of CSWB. The Executive Director also has the responsibility for interacting with the Ministry and several other Departments of the Central Government who are having programmes intended for empowerment of women. 
