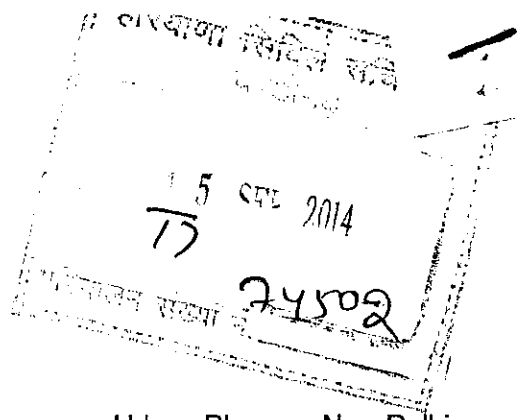

4. The appointment will be on transfer on deputation basis. The period of deputation shall ordinarily not exceed 4 years for JDC and 3 years for DDC. The selected officer will have the option to draw his/her grade pay plus deputation (duty) allowance, in accordance with Department of Personnel & Training's O.M.

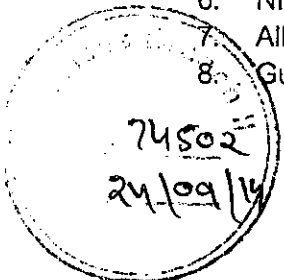
