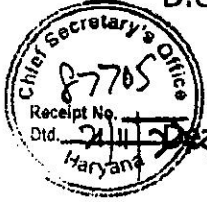

He also renders advice to the State Governments on various Acts, Rules and Regulations, formulated by the Government of India, whenever required.
