Sir/Madam,

It is proposed to fill up the post of Chief Executive Officer (CEO) & Managing Director(MD), Delhi Mumbai Industrial Corridor Development Corporation (DMICDC) under the Department of Industrial Policy & Promotion, Ministry of Commerce and Industry, in the pay band of Rs.37,400-67,000 (PB-4) and grade pay of Rs.10,000/- on deputation basis, initially for a period of three years, extendable by another two years, through Search-cum-Selection Committee.

2. DMICDC is a company covered under Section 619B of the erstwhile Companies Act, 1956. Delhi-Mumbai Industrial Corridor (DMIC) is India's ambitious Infrastructure programme aiming to develop new industrial cities as 'Smart Cities' and converging next generation technologies across infrastructure sectors. The objective is to expand India's manufacturing and service base and develop DMIC as a "Global Manufacturing and Trading Hub". CEO & MD is the chief executive of DMICDC having been entrusted with substantial powers of management subject to superintendence, control and directions of the Government of India and Board of DMICDC. The candidates for the assignment shall be of Joint Secretary level from All India Services or Central Services with experience in Industries/Commerce/Infrastructure Development/Public Private partnership/Management. The term of deputation shall be akin to deputation terms to other Government organization under Rule 6 (i) of the IAS cadre rules. The selected officer will be allowed requisite exemptions in the matter of empanelment, cooling off requirement before appointment, housing and CGHS facilities. The ACRs pertaining to the officer will be written and reviewed by Secretary, DIPP and accepted by the Minister for Commerce & Industry.

3. It is requested that this may be circulated among all the eligible officers in the Ministries/Departments, States/UTs and nominations of eligible and willing candidates may be forwarded in the enclosed proforma to this Department through proper channel and addressed to the undersigned, within 20 days from the date of issue of this vacancy circular along with the complete ACR/APAR dossier, vigilance clearance with the certification that no disciplinary proceedings or criminal proceedings are either pending or being contemplated against the officer concerned. In addition, Integrity certificate and list of major/minor penalties, if any, imposed on the candidate during the last ten years/No penalty certificate should also be sent.
