- The Departmental Officers in the feeder category who are in the direct line of promotion will. not be eligible for consideration for appointment on deputation (including short term contract). Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
- Period of deputation(including short term contract) including period of deputation(including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed five years. The maximum age limit for appointment on deputation (including short term contract) shall be not exceeding 56 years as on closing date of receipt of applications.
