Chief Vigilance Officer in the pay scale of Rs.32900-58000 (pre-revised Rs.16000-20800) in Mumbai Port Trust on deputation basis, from officers of Major Port Trusts holding analogous posts or officers holding posts in the payscale of Rs.24900-50500 (Rs 13000-18250 pre-revised) with 3 year regular service in the grade in Major Port Trusts as well as from officers of Central Government/ State Government/ PSUs/ Autonomous Bodies with similar grade, in terms of the Recruitment Rules under the MbPT Employees (RSP) Regulations, 2010. Copy of the Recruitment Rules is at Annexure I.

2.1 Eligible and willing officers of all Major Port Trusts /Central Government/ State Government/ PSUs/ Autonomous Bodies, fulfilling the prescribed qualification, experience and other criteria/ requirements as per the Recruitment Rules may forward their applications through proper channel so as to reach this office **latest by 11.9.2015**. The crucial date for determining eligibility is 1.8.2015 in terms of Regulation 10(2) of the MbPT Employees (RSP) Regulations, 2010.

2.2 The applicant should have at least 4 years service left as on 1.8.2015 for retirement on superannuation in the present organization for deputation posting.

3. Applications should be made in the format at Annexure II and should be submitted through proper channel, along with copies of all required documents.

4. Applications should be forwarded by the concerned Port Trust/ Organizations to the undersigned along with the following:

- Certificate on the last page of the application form duly certified by the HOD;
- Certified copies of ACRs for the last 5 years (1.4.2010 to 31.3.2015) (duly attested by an officer not below the rank of Dy. HOD on each of the page);


