Officers under the Central Government or State Governments or Union Territories or Universities or recognized Research Institutions or public sector undertakings or Semi Government or Autonomous or Statutory organizations :-

(a)(i) holding analogous post on regular basis in the parent cadre or department; or
ii) with five years' service in the grade rendered after appointment thereto on a regular basis in the pay band-3, Rs.15600-39100/- with grade pay of Rs.5400 or equivalent in the parent cadre or department; and

(b) possessing the following educational qualifications and experience:-

Essential:

(i) Master's degree from a recognised University or institute;
(ii) Degree or Diploma in Education or Adult Education or Sociology or Psychology or Statistics from a recognised university or institute;
(iii) Five years' experience in conducting research or evaluation of adult education or production of literacy materials or books in a Government department or university or commercial organization or training of personnel in adult education including functional literacy programme.

Desirable:

(i) Doctorate degree in Education or Adult Education from a recognised university or institute.

Note 1: The Departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

(The period of deputation (including short term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed four years. The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding fifty six years as on the closing date of the receipt of applications.

Note 2: For purposes of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006 or the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extended only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.
