

OFFICE MEMORANDUM

Subject: Inviting nominations for the posts of Executive Director (Finance) and Executive Director (Rehabilitation and Resettlement) in Pancheshwar Development Authority, Nepal.

In continuation to and in partial modification of this Ministry's O.M of even number dated 24.7.2015 and 17.9.2015, the undersigned is directed to refer to the subject mentioned above and to inform that the Government of India intends to nominate officers for holding the following posts in the Pancheshwar Development Authority, Nepal (PDA), a Joint Venture between Government of India and Government of Nepal to be headquartered at Mahendranagar, Nepal:-

- i) Executive Director (Finance)
- ii) Executive Director (Rehabilitation and Resettlement)

The emoluments for the above posts are to be decided by PDA, however, the Govt. of India has recommended the following pay and perks for these posts:-

Pay in Pay Band-4 (Rs.37400-67000) + Grade Pay (Rs.10000/-) + Foreign Compensatory Allowance (Rs.188893.6/per month). In addition to the salary, officers will be entitled for accommodation, medical reimbursement, etc., admissible as per rules

The eligibility conditions for selection for these two posts are as under:-

(i) Executive Director (Finance):

Serving Officers belonging to organized Finance/ Accounts Services under the Central Govt. or Govt. of States or Union Territories or Central/ State Govt. Public Sector Undertakings/ Autonomous Bodies/ Recognized Research Institutions/ Statutory Organizations of Govt. of India, holding analogous posts on regular basis, i.e., posts carrying pay in the Pay Band-4 with Grade Pay of Rs.10000/-.

OR

Serving Officers belonging to organized Finance/ Accounts Services under the Central Govt. or Govt. of State or Union Territories or Central/ State Govt. Public Sector Undertakings/ Autonomous Bodies/ Recognized Research Institutions/ Statutory Organizations of Govt. of India serving in the PB-4 (Rs.37400-67000/-) + GP Rs.8700/- with 3 years of regular service in the Grade.

- (ii) Executive Director (Rehabilitation & Resettlement):
- (a) Serving Officers belonging to the Central Govt. or Govt. of States or Union Territories or Central/ State Govt. Public Sector Undertakings/ Autonomous Bodies/ Recognized Research Institutions/ Statutory Organizations of Govt. of India, holding analogous posts on regular basis, i.e., posts carrying pay in the Pay Band-4 with Grade Pay of Rs.10000/-.

- (b) Possessing the following qualifications and experience:-
 - (ii) <u>Essential Qualifications:</u> A degree or equivalent in Civil or Environmental Engineering from a recognized university.

OR

Masters Degree with specialization in Forestry/Agronomy/Ecology/Sociology/Environmental Science from a recognized University or equivalent.

- (ii) Experience: Minimum 3 years' experience in the field of Impact Assessment for major irrigation projects including Rehabilitation & Resettlement of Project Affected Persons, Forestry, Environmental Management, Research etc.
- 3. The tenure of the posts, service conditions, other relevant terms and conditions etc. will be decided by the PDA, Nepal. However, the initial appointment will be for a period of three years.
- 4. The selection of officers to be nominated by the Government of India will be made by a Search-cum-Selection Committee constituted in this Ministry for this purpose. The Search-cum-Selection Committee may, at its discretion, call the shortlisted officers for personal interaction. The selected officers will be required to be relieved immediately on selection to enable them to join PDA.
- 5. It is requested that nomination of suitable officers belonging to Organised Central Services/Services under State/UT Govt./ State Govt. Public Sector Undertakings/ Autonomous Bodies/Recognized Research Institutions/ Statutory Organizations of Govt. of India, who are willing to serve in Pancheshwar Development Authority, Nepal and are clear from Vigilance Angle may be sent to this Ministry, alongwith the Bio-Data (as per enclosed format), APAR dossier for the past five years and cadre clearance so as to reach this Ministry latest by 02.11.2015 at the following address -
