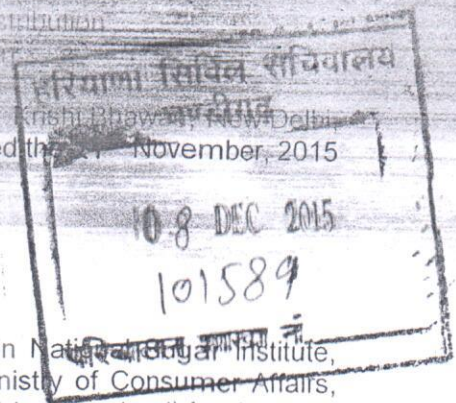

Subject: Filling up the post of Professor of Sugar Engineering in National Sugar Institute, Kanpur, Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution on deputation (including short-term contract) basis.

Sir,

In continuation to this Department's vacancy circular dated 30th June 2015 for the aforesaid post, I am directed to inform that advertisement for the post has been advertised in the 07 - 13 November, 2015 issue of the Employment News. In this connection, I am directed to invite applications from eligible and suitable officers for filling up of one post of Professor of Sugar Engineering, a General Central Service Group 'A' Gazetted Non-Ministerial post in the pay Band of Rs. 37,400-67000 (PB-4) + Grade Pay of Rs.8700/- in the National Sugar Institute, Kanpur, a subordinate office in the Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution on deputation (including short-term contract) basis. Details of the post, eligibility conditions etc. are given in the **Annexure I**.

2. Applications of only such officers/candidates will be considered as are routed through proper channel and are accompanied by:

- (i) Bio-data (in triplicate) as in the proforma at **Annexure -II**.
- (ii) Photocopies of Confidential reports/dossiers, for the last five years, duly attested by an officer not below the rank of Under Secretary to the Govt. of India.
- (iii) Vigilance clearance, Integrity Certificates and statement of major/minor penalties, if imposed during the last ten years, in the proforma at **Annexure -III**.

It is therefore, requested that the applications of suitable and eligible officers for the post may please be sent to the Under Secretary (SA), Ministry of Consumer Affairs, Food & Public Distribution, Department of Food & Public Distribution, Room No. 258, Krishi Bhawan, New Delhi-110001, within 60 days from the date of advertisement of the vacancy in the Employment News. Unsigned/incomplete applications not submitted through proper channel or those received after the last date shall not be considered.

It is requested that wide publicity may be given to this vacancy circular and the circular may please be circulated among all Autonomous bodies/Public Sector Undertakings/Statutory Organizations/Universities/Recognized Research Institutes/ Semi Government Organizations under the administrative control of the concerned Ministry/Department.

4. Pay Scale: Rs. 37,400 – 67000 (PB-4) + Grade Pay of Rs.8700/- (pre-revised scale of Rs.14300-400-18300/-).
5. Age Limit: The maximum age-limit for appointment by deputation shall be not exceeding 56 years as on the closing date for receipt of applications.
6. Eligibility conditions for appointment on deputation (including short term contract) basis:
Officers of the Central/State Governments/Union Territories/ Universities/ Recognized Research Institutes/ Public Sector Undertakings/Semi Government/Autonomous or Statutory Organizations:-
 - a) (i) holding analogous posts on regular basis
or
(ii) with five years' regular service in posts in the scale of Rs. 12,000 – 16,500/18000 (Rs. 3700-5000/5700 Pre-revised) (Revised to Rs.15600-39100 (PB-3)+ Grade Pay of Rs.7600/- as per 6th CPC) or equivalent, and
 - b) Possessing the educational qualifications and experience prescribed as under:-

ESSENTIAL:

- (i) Degree in Mechanical or Electrical Engineering of a recognized University or equivalent.
- (ii) Twelve years' research/practical/teaching experience at degree level in Mechanical/ Electrical/ Sugar Engineering.

DESIRABLE:

- i) Post Graduate/Research Degree in relevant branch of Engineering or Associateship of Sugar Institute (ANSI) (Sugar Engineering) after having completed Bachelor of Engineering (BE) (Mechanical or Electrical) of a recognised University or equivalent.
- ii) Degree level teaching experience of two years.
- iii) Three years experience of designing/erecting of modern sugar plant.

NOTE:

- (i) Qualifications are relaxable at the discretion of the Union Public Service Commission in case of candidates otherwise well qualified.
- (ii) The qualification(s) regarding experience is /are relaxable at the discretion of the UPSC, in the case of candidates belonging to the Scheduled Caste and the Scheduled Tribes, if at any stage of selection, the UPSC is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies for them.
- (iii) Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly deputationists shall not be eligible for consideration for appointment by promotion.

(iv). Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed five years. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of the receipt of applications.

7. Place of Posting:

The place of posting will be National Sugar Institute, Kanpur (UP), but liable to be posted anywhere in India.

8. Duties attached to the post:

- (i) Teaching, Research and rendering advice to Sugar Industry & allied industries.
- (ii) Any other work assigned by Director, NSI, Kanpur.
