The officer should be clear from Vigilance angle. (iii)

The officer should not have been debarred for Central Deputation. (iv)

The officer should have at least "Very Good" service record. However, preference would be given to officers who have 'Outstanding' service record with a grading of 9 and above.

The officer should not be over 54 years of age.

The officer should not have been posted on an assignment in a foreign/captive post of the GOI, earlier.

The officer should not have been nominated for foreign training or should not be on training or foreign assignment, currently;

The officer should not be on study leave or long leave.

Desirable qualifications

Experience in the areas related to Infrastructure Development/International Trade/Public Finance in the Ministries/Departments of the Government of India or in the State Government.

Experience in Externally Aided Projects.

Degree in Economics/Management/Public Finance/International Trade.

This post may be circulated amongst eligible officers and names of willing and eligible officers who can be spared by the State Governments/Ministries/Departments may be forwarded to this Department along with Cadre clearance, vigilance clearance, detailed Bio-data and ACR Dossier/certified ACR gradings for the last five years. It may also be ensured that "Cooling Off", after a previous stint on deputation, if any, is complete and the officer is eligible for Central Deputation. In case the officer is currently under central deputation, the nomination may be forwarded with the approval of the Minister in charge concerned and along with cadre clearance.
