This post is a General Central Service, Non Ministerial Group 'A' Gazetted post in the PB-4 (Rs. 37400-67000) with Grade Pay of Rs. 8700/-.

## Eligibility:-

Officers of the Central Government or State Governments or Union Territory or Autonomous Bodies or Public Undertakings or Statutory Organisations or Universities or Semi-Government Organisation:

- (a) (i) holding analogous posts on regular basis; or
  - (ii) with five years regular service in posts in the Pay Band -3( Rs. 15600-39100), Grade Pay Rs.7600/-; and
