- (i) holding Analogous Post on regular basis in parent cadre or Department; or
- (ii) with 3 years regular service in the scale of pay of Rs. 37400-Rs. 67000 with Grade Pay Rs. 8700 in PB-4 or equivalent in parent cadre or Department.
- 3. The deputation with NCCT/VAMNICOM will be on Foreign Service terms and conditions.
- 4. The period of deputation (including short term contract) period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment, in the same or some other Organization/Department of the GOI shall ordinarily not exceed three years.
