The post of Director in the pay scale of Rs. 37400-Rs. 67000 with Grade Pay of Rs. 10,000 in PB-4 is proposed to be filled up in Vaikunth Mehta National Institute of Management (VAMNICOM), Pune, an Apex Training and Management Institute under National Council for Cooperative Training (NCCT), on deputation failing which on contract basis for a period of 3 years, through search-cum-selection process. NCCT is a Committee set up with the approval of GOI under bye law 16 A of National Cooperative Union of India (NCUI), a Multi State Coop. Union registered under MSCS Act, 2002 - for promotion and development of Cooperative Training.

2. The eligibility criteria for appointment to the post of Director (VAMNICOM) is as under:-

(a) Essential: Full time post-graduate degree/diploma with minimum 55% marks in social science/economics/cooperation/Commerce /business administration/agricultural/information technology from a recognised university or Institute.

(b) Desirable: (i) PHD in relevant subject (ii) HDCM/Diploma/PG Diploma in Cooperative Management.

(ii) Essential experience:

Minimum 15 years Administrative & Academic experience in senior executive capacity or Head of the Institutions in recognised University/Institute/Cooperative training Organisation/Cooperative Institute/ Cooperative Department/Govt. Organisations/Semi-Govt./PSUs/Autonomous Body and

- (i) holding Analogous Post on regular basis in parent cadre or Department; or
- (ii) with 3 years regular service in the scale of pay of Rs. 37400-Rs. 67000 with Grade Pay Rs. 8700 in PB-4 or equivalent in parent cadre or Department.

3. The deputation with NCCT/VAMNICOM will be on Foreign Service terms and conditions.

4. The period of deputation (including short term contract) period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment, in the same or some other Organization/Department of the GOI shall ordinarily not exceed three years.


5. Officer selected will have the option to draw his grade pay plus deputation (duty) allowance or to have his pay fixed in the pay scale of the post in accordance with the Department of Personnel & Trainings O.M. No. 2/29/91-Estt. (Pay-II) dated 5.1.1994 as amended from time to time.

6. Applications in the enclosed proforma, of interested and eligible officers who can be spared in the event of their selection may be forwarded, in duplicate to this Department within 45 days from the date of advertisement of this vacancy in the Newspaper. While forwarding the applications, it is mandatory to verify and certify that the particulars furnished by the officer are correct. The following documents also need to be sent along with the application:-

- (i) Vigilance clearance that no vigilance case is either pending or contemplated against the candidate;
  - (ii) Integrity Certificate;
  - (iii) Major/Minor penalty statement during lasts ten years;
  - (iv) Cadre clearance from the cadre controlling/appointment authority, if applicable; and
  - (v) photocopies of ACRs/APARS of last 5 years duly attested on each page. If for some reasons, the ACRs/APARS of the officer have not been written for a particular year or a part (for more than three months) of a year, a "No Report Certificate" (NRC) for that period may be sent along with ACRs/APARS of the corresponding previous years (s).
7. The maximum age limit for this appointment by deputation/including short term contract should not exceed 56 years as on the closing date of the receipt of applications.
