



DDA invites applications from the eligible officers of Central/State Govt. for filling up 02 posts of Director (Ministerial) in the Pay Band - 3 i.e. Rs.15,600-39,100/- with Grade Pay of Rs.7600/- (as per 6th CPC) in Delhi Development Authority on deputation basis in accordance with the following provisions of the recruitments regulations.

"Officers belonging to Central Govt./State Govt.


- (i) Holding analogous post on regular basis in the parent department/cadre; or Officers With .05 years regular service in posts in PB-3 Rs.15,600-39,100/- with Grade Pay of Rs.6,600/- or equivalent
- (ii) Possessing a Bachelor's degree from a recognized university or equivalent."

Transfer of Deputation will be initially for a period of one year which is extendable upto 05 years on year to year basis as per guidelines issued by DoPT.

2. General Conditions :

- (i) Candidates should apply in the prescribed format through their Cadre Controlling Authority in the Parent Department/Organization in the format enclosed herewith. (See DDA's Website)
- (ii) While forwarding the application, Cadre Controlling Authority in the Parent Department must certify the details furnished by the candidates and application must be recommended and forwarded to DDA by the Cadre Controlling Authority in the parent department along with certified copies of APARs for the last 05 years and the latest Vigilance Clearance Report.
- (iii) Applications received after the last date shall not be entertained.
- (iv) The officers will be posted purely on transfer on deputation basis. No absorption shall be allowed.
- (v) The eligibility of the officer will be reckoned as on the last date of receipt of application in DDA.

4. The applications complete in all respects should reach the office of Commissioner (Personnel), Delhi Development Authority, E-1, Vikas Sadan, INA, New Delhi-110023 by 01.02.2017. Incomplete applications shall not be considered and will be summarily rejected.
