2. In case of individuals selected from private sectors they must possess essential qualifications stated above. They shall be engaged on short term contract basis for a period of one year from the date of joining. They shall be paid a consolidated sum of Rs.89,876/- per month. They shall be required to furnish a Bond to the Government of Puducherry to continue to function as the Director of Ports, Puducherry for the period of one year. If they decide to leave the service before the expiry of the contract, they shall be required to pay the Government of Puducherry a sum equivalent to three months pay being paid to them.

3. Qualifications regarding experience are Relaxable in case of candidates otherwise well qualified.




