2. The post of Secretary in the Bureau of Energy Efficiency (BEE) carries the scale of pay of PB-4 Rs. 37400-67000 + Grade Pay of Rs. 8,700 (pre-revised). The officer selected for appointment will be entitled to draw pay/deputation allowance + other allowances as per Central Government Rules.

- 3. The appointment to the post of Secretary shall be made on deputation from amongst officers of the Central/State Government or Statutory or Autonomous Bodies under the Central or State Governments, holding a post not below the rank of Deputy Secretary to the Government of India. The desirable experience for the post are:- (i) 5 years experience in the field of generation, transmission, distribution of power or energy conservation; (ii) 5 years experience in administrative, financial and budgetary matters.
- 4. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall ordinarily not exceed five years. The maximum age limit for appointment by deputation shall not exceed fifty six years as on the closing date of receipt of applications.
- 5. The Secretary shall hold office for a term of three years, from the date on which he/she enters upon his/her office or, the date of his/her superannuation in his/her parent cadre, whichever is earlier. The term of deputation can be extended where considered
