Five years' of experience in teaching or research or extension work, including aspects related to Storage and preservation of food grains in Government organizations or Public Sector Undertakings or Universities.

Note 1. The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion. (Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed four years.) The maximum age limit for appointment on deputation (including short-term contract) shall be not exceeding 56 years, as on the closing date of receipt of application.
