After taking over the charge as DG, HIPA in December, 2016, I have been trying to streamline the various activities of HIPA, especially in the area of training. However, I have not been able to devote adequate time and attention to the Administration of HIPA, which is full time job to be handled by a 2nd in Command. There is a post of Additional/Executive Director provided in the HIPA Administrative Service (A, B, C, & D) Bye-Laws, 2005, which is to be filled by deputation from the amongst IAS Officers of Haryana State Government. For assisting the Additional/Executive Director in this work there is a post of Joint Director and Ms. Ekta Chopra, HCS has been posted as Joint Director. Although she is competent officer and has been satisfactorily handling the duties assigned to her, she does not have required experience to work as a 2nd in Command. There are several meetings at Govt. of India level which are to be attended either by the Director General himself or by Additional/Executive Director. Since it has not been possible for me to attend most of the meetings, I had no option but to depute a faculty member. It will be in the interest of HIPA that a sufficiently senior officer attends such meetings. Therefore, I request that a Commissioner level IAS officer may be appointed on deputation as Additional/Executive Director so that the work of administration and coordination does not suffer. If it is not possible to post a serving officer, Government may consider posting a retired IAS officer of a suitable seniority.

Kindly treat this matter as most urgent.

Provided that the Government may, if satisfied that such marriage is permissible under the Personal Law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

2. No person, who has been dismissed from the service of the Government of India or any State Government or a local authority, a Corporation or Institute, shall be eligible for appointment to any post in Group-A, B, C & D Service.

9. Method of Recruitment:

The posts in Service shall be filled in the following manner:-

GROUP - A:

1. In the case of Director/Director General:

by deputation from amongst IAS Officer of the Haryana State Cadre, declared equivalent in status and responsibility to the post of Secretary to Government in Commissioner's rank. In case the officer is equivalent in status and responsibility to the post of Principal Secretary to Government in the rank of Financial Commissioner or above he shall be designated as Director General.

2. In the case of Additional Director/Executive Director:

by deputation from amongst IAS Officer of the Haryana State Cadre

3. In the case of Under Secretary:

by deputation from amongst HCS/HSS Officers. In case an officer of such cadre in a higher scale is posted on deputation such officer shall draw his own pay scale.
