It is, therefore, requested that the above vacancy may be circulated to all the organizations including PSUs, Semi-Government / Statutory OR Autonomous Organizations under your administrative control and the applications of suitable officers, who can be spared for joining the post in the event of their selection, may be forwarded only through proper channel in the prescribed pro-forma (as per the specimen given in Annexure II attached to this O.M.), along with (i) photo copies of the Annual Confidential Reports (ACRs) of the applicants for the last five years duly attested by an Officers NOT below the rank of Under Secretary or equivalent; (li) a certificate from the employer that no disciplinary / vigilance case is either pending or being contemplated against the Officer, (iii) a statement indicating the details of major / minor penalties, if any, imposed on the officer during the last 10 years, (iv) integrity certificate duly signed by the competent authority, and (v) Cadre clearance, by name to The Chairman, Council for Leather Exports, CMDA Tower II, 3rd Floor, Gandhi Irwin Bridge Road, Egmore, Chennal-600 008 with in one month from the date of publication of the advertisement. Applications received after the last date or without confidential reports and other requisite documents or otherwise found incomplete will not be considered.
