It is proposed to fill up the post on deputation (including short-term contract) basis. The post of Controller of Stationery is a Group 'A' post in Level 12 in the Pay Matrix as per the 7th CPC [pre revised Pay Band-3 Rs.15,600-39,100/- (+) Grade Pay Rs.7,600/-].

- The Controller of Stationery functions as a Head of the Department under the control withis Ministry and is vested with all the statutory powers in the post on the matters related to funance, legal, disciplinary and administrations. Besides this, he is also responsible for planning, procurement, storing and supplying the stationery stores to the indenting Ministries / Departments. The Headquarters is at 3 Church Lane, Kolkata-700001 with Regional Stationery Depots at New Delhi, Mumbai and Chennai.

- (ii) Possessing ten years' experience in the field of Stationery and Stores.

NOTE: The Departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputationist shall not be eligible for consideration for appointment by promotion.
