The Additional Director(Agrl. Engg.) will have to function as the Head of the Agricultural Engineering Wing and will have to draw out broad based engineering programmes under Farm Mechanisation, Soil and Water Conservation and Groundwater Development for implementation in this Union Territory. He will have to oversee all the engineering activities and formulate the plans of action and action schedules for all the engineering schemes. He has to scrutinize the estimates prepared for the works to be undertaken under various engineering programmes and accord technical sanction as per the delegation of powers.
