I. COMPANY PROFILE

SJVN Limited (formerly Satluj Jal Vidyut Nigam Limited) was incorporated on 24 May 1988 under the Companies Act 1956 as a Joint Venture of the Government of India & Government of Himachal Pradesh, with the objective to "Develop Power Projects, in India and Abroad Optimally and Economically."

SJVN Limited is a Schedule "A" Miniratna CPSE in power sector and is listed in NSE and BSE. The Company is a profit making organization and has consistent track record of dividend payment.

The present installed capacity of SJVN Limited is 1964.85 MW (comprising of 1912 MW Hydro + 47.6 MW Wind Power + 5.26 MW Solar Power). The Company, at present, is implementing (under various stages of development) 10 Hydro Power Projects totalling 3,200 MW (7 Projects - 1,130 MW in India, 3 Projects of 2,070 MW in neighbouring countries of Nepal & Bhutan), one 1320 MW Thermal Power Project at Buxar in state of Bihar and 50 MW Sadla Wind Power Project in Gujarat. SJVN commissioned 86 km 400 kV double circuits Indo-Nepal Cross Border Power Transmission corridor between Dhalkebar (Nepal) and Muzzafarpur (India) on 17.02.2016 in JV with Power Grid, IL&FS and Nepal Electricity Authority.

Its Registered and Corporate offices are in Shimla, Himachal Pradesh.

The authorized and paid up capital of the Company is Rs.7,000 crores and Rs. 4,136.63 crores respectively as on March 31, 2017.

The shareholding of the Government of India in the company is 64.46% and that of Government of Himachal Pradesh and public is 25.51% and 10.03% respectively.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Director(Civil) is a member of Board of Directors and reports to Chairman and Managing Director. He/She is responsible for the design and construction works of the projects. He/She would assist the Chairman and Managing Director in these matters in the Corporate Office. As a Functional Director, he/she will have a dual role, viz: helping in shaping the policies of the Corporate Office and in reviewing and monitoring the overall performance. As Director Incharge of the Construction and Design Wing, he/she would be responsible for the execution of his/her functional responsibilities.

2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and not in a contractual/ad-hoc capacity – in one of the followings:-

- Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);
- Central Government including the Armed Forces of the Union and All India Services;
- State Public Sector Enterprise (SPSE) where the annual turnover is *Rs 2000 crore or more;
- Private Sector in company where the annual turnover is *Rs 2000 crore or more.

(* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)

3. QUALIFICATION:

The applicant should be an engineering graduate preferably in Civil Engineering with good academic record from a recognized University/Institution.

Applicants holding MBA/PGDM qualification will have added advantage.

4. EXPERIENCE:

The applicant should possess adequate technical/operations experience at a senior level in an organization of repute, out of which at least five years during the last ten years should be in one or more areas of Construction, Planning, Design, engineering, Operation & Maintenance of Hydro Electric Projects.

5. PAY SCALE/ RANK/ LEVEL:

The minimum length of service required in the eligible scale/rank/level will be one year for internal candidates, and two years for others as on the date of vacancy.

Applicants from State Public Sector Enterprises/ Private Sector should be working at Board level position or at least a post of the level immediately below the Board level.

6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

IV. DURATION OF APPOINTMENT

The appointment shall be for a period of five years from the date of joining or upto the date of superannation or until further orders, whichever is earlier.

V. SUBMISSION OF APPLICATIONS

- (f) Private Sector: directly to the PESB.

2. Applicants from Private Sector must submit the following documents along with the application form:

- (a) Annual Reports of the Company in which currently working for the 3 financial years preceding the calendar year in which the post is advertised (please provide URL or attach/enclose copies);
- (b) Whether the company is listed or not; if yes, the documentary proof (please provide URL or attach/enclose copies);
- (c) Evidence of working at Board level or at least a post of the level immediately below the Board level;
- (d) Self-attested copies of documents in support of age and qualifications;
- (e) Relevant Jobs handled in the past with details.

VI. UNDERTAKING BY THE APPLICANT

An applicant has to give an undertaking as a part of the application that he/she will join the post, if selected. If an applicant does not give such undertaking, the application would be rejected.

2. For candidates from CPSE

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
