It is proposed to fill up the post of Director (Finance) in National Disaster Management Authority (NDMA) under M/o Home Affairs on deputation basis.

- The officers of the rank of Deputy Secretary/Director of the Government of India or equivalent level eligible for appointment under the Central Staffing Scheme are eligible for the post. The period 2. of deputation is 4/5 years for Deputy Secretary/Director respectively.
- The post may be circulated amongst officers eligible to be appointed at Deputy Secretary/Director or equivalent level in the Government of India on priority basis. Names of willing and eligible officers who can be spared by the State Governments/Ministries/Departments may be forwarded to the Department alongwith cadre clearance, vigilance clearance, detailed bio-data in the enclosed proforma and CR Dossiers of last five years. For officers working in the cadre, i may also be ensured that the 'Cooling off' after a previous stint on deputation, if any, is complete and the officer is eligible to be appointed on Central Deputation as per instructions.
 - The post is a Non-Central Staffing Scheme post to be filled up through the Civil Service Board (CSB) procedure. It may be noted that no 'Mandatory Posting Certificate' fc allotment/retention of Government accommodation would be issued by this office to the office appointed on the above referred post. However, those officers who have served and are current serving on Central Staffing Scheme post in Delhi for at least four years and require to retai Government accommodation, would be issued a certificate to the effect that the officer concerns has served at least four years in CSS post and he/she needs to retain Government accommodation for his/her tenure on non-CSS post.
