

### **CIRCULAR**

Subject: Filling up of posts of Directors/ Financial Advisor in Food Safety and Standards Authority of India on deputation / short term contract -reg.

It is proposed to fill up various posts in FSSAI Head Quarters / Regional Offices on transfer on deputation on Foreign Service terms including short terms contract as per details contained in <u>Annexure-1</u> of this circular. Officers fulfilling the eligibility criteria & experience as in Annexure – I may apply in the prescribed Performa (Annexure-II).

- 2. The Food Safety and Standards Authority of India (FSSAI) is an autonomous statutory Authority set up under the Food Safety and Standards Act, 2006 for laying down science based standards for articles of food and to regulate their manufacture, storage, distribution, sale and import, to ensure availability of safe and wholesome food for human consumption.
- 3. The terms of deputation including pay of the officials selected on deputation will be governed by provisions laid down in the Department of Personnel and Training's No.6/8/2009-Estt.(Pay II) dated 17<sup>th</sup> June, 2010.
- 4. The initial period of deputation in FSSAI shall be three years. The period of deputation, in case of employees already on deputation in another extender post including, the period of deputation held immediately preceding this appointment in the same or some other organization/Department shall not exceed five years. The maximum age limit for appointment on deputation shall be 56 years on the last day of receiving the applications.
