Dear Sir.

Chhattisgarh State Electricity Regulatory Commission (CSERC) has been notified by the Government of Chhattisgarh under the provisions of the Electricity Act, 2003. The Commission consists of a Chairperson and one Member. Tenure of present Member of Chhattisgarh State Electricity Regulatory Commission (CSERC) is ending on 28.10.2016 on attaining 65 years age.

2. The Government of Chhattisgarh, Department of Energy, has constituted a selection committee for selection of a panel of suitable candidates for the post of Member in Chhattisgarh State Electricity Regulatory Commission (CSERC). Member of the Commission shall be person of ability, integrity and standing who has adequate knowledge of, and has shown capacity in dealing with problems relating to Engineering, Finance, Commerce, Economics, Law or Management.

3. I am to request you to propose the names of interested and suitable persons for the post of Member, CSERC along with their bio-data. The Member shall hold the post for a term of five years from the date on which he/she enters upon office or till he/she attains the age of 65 years, whichever is earlier. Other conditions of service would be as provided in the Electricity Act 2003. The Member is entitled to pay scale of Principal Secretary to the State Government (Rs. 67,000 - 79,000) and other allowances as per rules. If the incumbent draws pension, then he/she will be entitled to get the pay after deduction of the pension amount.

4. I shall be grateful if you could forward proposals of suitable persons for the post of Member having qualification and experience as prescribed in the Electricity Act 2003 so as to reach us by evening of 10th October 2016. While forwarding proposals you may kindly make sure that the person proposed does not have any financial or other interest which is likely to prejudice his/her functions as Member, CSERC.

5. The Bio-data of the proposed candidate should include following details:-

Name, age and date of birth, position now held, educational qualification and details of posts previously held with experience in any of the field of Engineering. Finance, Commerce, Economics, Law or Management.

The proposal should also contain a letter from the person proposed intimating the details of any office, employment or consultancy, agreement or arrangement which he/she has in his/her own name or in any firm, association of persons or body corporate, or in the names of any relative, carrying on any of the following business, namely:-

- (i) Generation, Transmission, Distribution or Supply of Electricity.
- (ii) Manufacture, sale or supply of any fuel for generation of electricity.
- (iii) Manufacture, sale, lease, hire or otherwise, supply of or dealing in machinery, plant equipment, apparatus or fittings for the generation, transmission, distribution, supply or use of electricity, and
- (iv) any entity providing professional services to any of the business referred in sub-clauses (i). (ii) and (iii) above.

In addition to the above details, proposal should also include a letter of willingness to resign his/her present post and to join CSERC, if selected.
