Applications are invited from officers who have retired from the Sainik & Ardh Sainik Welfare Department from the posts of District Sainik & Ardh Sainik Welfare Officer for re-employment for the period of one year **or** till the regular officers join through direct recruitment whichever is earlier, as per detail given below:

Terms and Conditions for filling up the above said posts are as under:-

1. This re-employment will be for a period of one year from the date of re-employment orders or till the regular incumbent join through direct recruitment, whichever is earlier.
2. Good service record shall be non-negotiable. More than 70% of ACRs of the officers should be good or above and no disciplinary or judicial proceedings should be pending at the time of retirement. There should be no adverse remarks regarding integrity during last ten years before of retirement.
3. The Haryana Civil Services (Government Employees' Conduct) Rules, 2016 & Haryana Civil Services (Punishment & Appeal) Rules, 2016 would be applicable during the period of re-employment.
4. Pay and allowances would be admissible as per provision in Haryana Civil Services Rules, 2016.
5. The Government reserve the right to rescind the re-employment of engaged officer and relieve him/her of the Charge at any time without notice, in case his/her work and conduct is not found satisfactory or the exigencies, so require.
6. They will be provided DA/HRA as provided in rule 27 of HCS (Allowance to Govt. Employees) Rules, 2016.
7. They shall perform such duties as assigned to him by the Government from time to time.
8. They will be entitled to medical concession admissible under the Haryana Government Medical Rules, 1940 and executive instruction issued by the Govt. from time to time.
9. The selected candidate shall be liable to serve at any place, whether within or outside the State Haryana, on being ordered so to do by the appointing authority.
10. The applicants should not be more than **Sixty three** years of age on the last date of submission of application.
