**Eligibility criteria for the one time cash award to PVSM, AVSM and VSM award winners**

1. All ranks in the Army, Navy, Air Force, will be eligible.
2. In the case of awardees who could not claim/receive one time cash award for the awards in their life time, widow / parents will be eligible for one time cash award on 50:50: basis 50% to parents and 50% to the widow provided she does not re-marry after the death of the awardess.
3. In case the awardee dies unmarried parents of the awardee are entitled to get the 100% award money in equal share 50: 50: basis (Step Mother and Step Father shall not be entitled to get the award money)
4. No other family members will be entitled to get the award money.
5. The recipients who had won these awards more than once or Bar to the decoration will be entitled to additional benefits as are applicable to each award.
6. One time cash award will not be admissible if such grant has been given by any other State Government to the awardees for that particular award.
7. The above rates will not be admissible to those recipients who have obtained cash award, monetary grant in lieu of land in terms of Govt. of Haryana Memo No. 20/28/85-Defence/BC-IV dated 25 Sept., 1986 subsequently superseded vide Memo. No. 20/28/85-Defence/BC-IV dated 27<sup>th</sup> April, 1988, and Memo No. 28/2/2005-4D-III dated 7.4.2006 which was discontinued vide Memo No.28/2/2005-4D-III dated 3.4.2007.
8. The recipients will be entitled to one time cash award on production of Domicile Certificate /Resident Certificate issued by competent authority of Haryana and attested copy of Ration Card.

9. The awardee must be a permanent domicile of Haryana State at the time of joining service and continue to be the permanent domicile of Haryana State at the time of award and continue to be domicile of Haryana till the date.
10. The awardee must apply for sanction of the awards within three years of the Gazette Notification of the award medal, there after it will be time barred.
11. The old awardees who received the award before issue of this notification and have not received the award money may apply within three months from the date of issue of this letter i.e. dated 31.3.2008 all the cases received after three months shall be treated time barred and will not be considered.
