Subject:- Enhancement of Financial Assistance to Para/Tetra/Hema Plegic ESM.

Kindly refer to this office Memo. No. 24/9/97- 4DIII dated 16.12.2004, on the subject cited above.

2. The State Govt. has been considering the question of enhancing the rates of financial assistance to Para/Tetra/Hema Plegic ex-servicemen for quite sometime. It has been decided to increase the rate of financial assistance to Para/Tetra/Hema Plegic ESM from Rs. 800/- P.M. to Rs. 1000/- P.M.
3. All other terms and conditions for grant of financial assistance to Para/Tetra/Hema Plegic ESM will remain unchanged.
4. The expenditure will be met out of Govt. budget under the Head "2235-Social Security and Welfare -60-OSSWP-200-OP(90) FA to Para/Tetra/Hema Plegic ESM-09 - GIA (Non-Plan).
5. **THESE INSTRUCTIONS WILL COME INTO FORCE W.E.F. 13.12.2006.**

Subject:- Enhancement of rates of Financial Assistance (F.A.) to Paraplegic/Tetra plegic/Hemiplegic Ex-servicemen.

In supersession of this office letter No. 47/1/OC/PP/4D-III dated 10th March 1992 on the subject noted above. I am directed to say that the matter of enhancement of Financial Assistance (F.A.) to the categories mentioned above, had been under the active consideration of the State Govt. for quit sometime past. It has now been decided to enhance the rates of F.A. from Rs. 600/- P.M. to Rs. 800/- P.M. w.e.f. 1.12.2004 for grant to Paraplegic/Tetra plegic/Hemiplegic Ex-servicemen.

2. Eligibility conditions for the grant of F.A. are given in the Annexure 'A&B' attached herewith which will be strictly adhered to while recommending forwarding the cases to Rajya Sainik Board for sanctioning the grant of F.A. to eligible persons.

4. The expenditure involved shall be debited to Major Head "2235-Social Security and Welfare -60-OSSWP-200-OP(90) FA to Para Tetra plegic ESM-09-GIA" (Non-Plan).

ELIGIBILITY CRITERIA

Eligibility criteria and conditions for grant of Financial Assistance to the Paraplegic ESM/Tetra plegic ESM and Hemi Plegic ESM @ Rs. 800/- P.M. w.e.f 1.12.2004 is as under :

1. F.A. shall be granted to those Paraplegic ESM/Tetra plegic ESM and Hemi Plegic ESM who are bonafide resident of the Haryana State and are not in receipt of any kind of F.A. from any Department of Haryana Govt.
2. (a) Definition of Ex-Servicemen for the purpose of the eligibility of F.A. shall be effective as notified by Ministry of Defence Govt. of India from time to time. (Annexure-B)
(b) In case of Paraplegic, Tetra plegic and Hemi Plegic ESM of Haryana State F.A. will be admissible to only those who are not fit to resettle in civil life on account of total incapacitation (100% disabled) and are penury.
(c) In case of Hemi plegic ESM of Haryana State financial assistance will be admissible to only those who after 6 months of the attack of the deceased, do not recover and who are also declared 100% disabled on account of Hemi plegic disease by the Medical authorities even after 6 months of the attack of the disease.
3. The financial Assistance will not be admissible to those Para Tetra Hemi plegic ESM who are admitted in para plegic homes run by Govt. of India or State Govts and are covered by grants to para plegic home.
4. The Financial Assistance is admissible to eligible Para/Tetra/Hemi plegic ESM in addition to any disability pension from Govt. of India, Ministry of Defence.
5. Original Discharge book issued by the concerned Record Office of the Ex-servicemen will have to be submitted by the applicant for scrutiny of the case which will be returned through respective Zila Sainik Board after scrutiny of the claim case.
6. All the applications received by the Zila Sainik Boards will be scrutinized at the level of Zila Sainik Boards itself and the applications found fit for grant of F.A. will be forwarded with all relevant documents to Rajya Sainik Board with clear recommendation of Secretary, Zila Sainik Board.

7. Every application for claiming the F.A. under this scheme will be supported by an affidavit prescribed form (Annexure-C) duly attested by Ist Class Magistrate containing all necessary information in support of the application.
- 8.. Every applicant under this scheme will submit Medical Certificate issued by Medical authority clearly stating the disease from which he is suffering from with % age of disability as required.
- 9 Subject to the condition that application/claim case is found in order Financial Assistance to the paraplegic/Tetra plegic and Hemi plegic ESM will be sanctioned with effect from the first day of the following month in which case is sanctioned by the competent sanctioning authority.
10. Before the release of F.A. concerned Welfare Organizer (W.O.) shall sign a written certificate on the F.A. grant roll that all the beneficiaries included in the F.A. grant roll are alive. Secretary, Zila Sainik Board will countersign the certificate given by the W.O.s on the F.A. grant roll and shall be personally responsible for any lapse or error.
11. However, old beneficiaries whose cases for grant of F.A. have already been sanctioned prior to issue of these guidelines shall continue to get the F.A. at enhanced rates as per Rs. 800/- P.M. w.e.f. 1.12.2004 and they need not apply afresh. However payment shall be discontinued with immediate effect who fails to submit their survival verification proofs every year from the revenue authorities.
12. Payment of F.A. to those beneficiaries shall also be stopped immediately who fail to submit their survival verification proofs every year from the revenue authorities in the month of April. Secretary, Zila Sainik Board shall be personally responsible for any lapse in this regards.
13. Every applicant shall have to produce a certificate issued by the concerned District Social Welfare Officer to the effect that applicant is not getting any F.A./ Pension/ widow pension from Social Justice & Empowerment Department of Haryana
14. If any beneficiary, after the sanction of the F.A. under this scheme is found drawing any type of F.A. from any other Deptt. of Haryana Govt. He/she shall be permanently debarred from getting the F.A. under all scheme.

**DEFINITION OF
EX-SERVICEMEN**

Definition of Ex-servicemen as adopted by Govt. of India Ministry of personnel, Public Grievances & Pensions, Deptt. of personnal & Training Memo No. 36034/5 85-Estt.(SCT) dated 27.3.1987.

DEFINITION OF EX SERVICEMEN**A. THOSE RELEASED ON OR AFTER 1.7.87**

An 'Ex serviceman' means a person, who has served in any rank whether as a combatant or non-combatant in the regular Army, Navy or Air Force of the Indian Union and

- (a) Who retired from such service after earning his pension or
- (b) Who has been released from such service on medical ground attributable to military service or circumstances beyond his control and has been awarded medical or other disability pension or
- (c) Who has been released otherwise than on his own request from such service as a result of reduction in establishment or
- (d) Who have been released from such service after completing the specific period of engagements, otherwise than at his own request or by way of dismissal or discharge on account of misconduct or inefficiency and has been even a gratuity and includes personnel of the Territorial Army of the following categories namely:-
 - (i) Pension holders for continuous embodied service.
 - (ii) Persons with disability attributable to military service and
 - (iii) Gallantry award winners.

NOTE : Personnel of Army postal service who are a part of regular army and are released from regular army only as per above conditions after 1.7.87 also come within the definition of ESM.

B. THOSE RELEASES ON OR AFTER 1.7.79 BUT BEFORE 1.7.87

An Ex-serviceman means :-

Any person who had served in any rank in the Armed Forces of the Union for a continuous period of not less than six months after attestation, if discharged for reasons other than :

(iv) At his own request or

(v) By way of dismissal or discharged on account of misconduct or inefficiency.

(vi) And not less than 5 years of service if discharged at his own request.

C. THOSE RELEASES ON OR AFTER 1.7.68 BUT BEFORE 1.7.79

An Ex-serviceman means :-

Any person who had served in any rank in the Armed Forces of the Union for a continuous period of not less than six months after attestation and released there from otherwise than by way of dismissal or discharged on account of misconduct or inefficiency.

D. THOSE RELEASED BEFORE 1.7.68

An Ex-serviceman means :-

Any person who had served in any rank in the Armed Forces of the Union and has been released there from otherwise than by way of dismissal or discharged on account of misconduct or inefficiency.

- NOTE** : (1) Personnel who have served in the Defence Security Corps. The General Reserve Engineering Force the LOK Sahayak Sena and the Para Military Forces are not Ex-servicemen within the meaning of the above definition.
- (2) In all cases Recruits are not ESM
- (3) The eligibility of the persons of the Status of Ex-servicemen will be governed by the definition in vogue at the time of his discharge and will not be affected by the changes in the definition subsequent to his discharge.
