Subject:- Enhancement of Financial assistance to the Disabled ESM who are not in receipt of any pension/FA.

Kindly refer to this office Memo. No. FA/DESM/4DIII dated 16.12.2004, on the subject cited above.

2. The state Govt. has been considering the question of enhancing the rates of financial assistance to the Disabled ex-servicemen for quite sometime. It has been decided to increase the rate of financial assistance to the Disabled ex-servicemen from Rs. 500/- P.M. to Rs. 1000/- P.M. who are not in receipt of pension or FA from any source.

3. Disabled ESM already receiving F.A. under the scheme "Financial Assistance to ESM above the age of 60 years" will continue to receive the F.A. at the rates of that scheme till their fresh application/cases are sanctioned by the Rajya Sainik Board for grant of F.A. under the scheme of "F.A. to disabled ESM".

4. All other terms and conditions for grant of financial assistance to the Disabled ex-servicemen will remain unchanged.

5. The expenditure will be met out of Govt. budget under the Head "2235-Social Security and Welfare -60-OSSWP-200-OP(88) FA to Disabled ESM-09 - GIA (Non-Plan).

6. **THESE I NSTRUCTIONS WILL COME INTO FORCE W.E.F. 13.12.2006.**

Subject:- Enhancement of rates of Financial Assistance (F.A.) to Disabled Ex-servicemen whose disability is even not attributable to Armed Forces Service.

Sir,

In supersession of this office letter No. FA/AMLF/86/1D-II dated 8.5.91 and letter No. FA/D.ESM/4D-III dated 4.8.1992 on the subject noted above. I am directed to say that the subject of enhancement of Financial Assistance (F.A.) to the Disabled ESM mentioned above, had been under the active consideration of the State Govt. for quit sometime. It has now been decided to enhance the rates of F.A. from Rs. 200/- P.M. to Rs. 500/- P.M. w.e.f. 1.12.2004 for grant of F.A. to Disabled ESM.

2. Eligibility conditions for grant of F.A. are given in the Annexure 'A&B' attached herewith which will be strictly adhered to while recommending forwarding the cases to Rajya Sainik Board for sanctioning the cases of grant of F.A. to eligible persons.

3. The expenditure involved shall be debited to Major Head "2235-Social Security and Welfare -60-OSSWP-200-OP(88) FA to Disabled ESM-09-GIA" (Non-Plan).

**ELIGIBILITY CRITERIA**

Eligibility criteria and conditions for grant of Financial Assistance to Disabled Ex-servicemen @ Rs. 500/- P.M. w.e.f 1.12.2004 who are not in receipt of any type of F.A. Pension from any source.

1. F.A. shall be granted to only those Disabled ESM irrespective of age who are discharged from Armed Forces on Medical Grounds and whose disability is not attributable to service.
2. Definition of Ex-Servicemen for the purpose of the eligibility of grant of F.A. shall be as adopted by Govt. of India w.e.f. 1.7.87 (Annexure-B)
3. Grant of F.A. shall be sanctioned only to those eligible ESM who :-
  - (a) Apply for grant of F.A. through respective Zila Sainik Boards covering the area of jurisdiction.
  - (b) Only bonafide residents of Haryana State are eligible for grant of F.A. and the applicants shall have to produce domicile certificate issued by the competent authority as authorized by Haryana Govt.
  - (c) Personnels in Civil employment shall not be eligible for the grant of F.A. henceforth.
  - (d) Every applicant shall have to attach Original Discharge book issued by the concerned Record Office of the Ex-servicemen for scrutiny of the case which shall be returned through respective Zila Sainik Boards after consideration of the application.
  - (e) (i) Every applicant shall have to produce a certificate issued by the concerned District Social Welfare Officer to the effect that applicant is not getting any F.A. Pension from the District Social Welfare Department of Haryana

(ii) If any beneficiary receiving F.A. under this scheme, after the sanction of F.A. any time is found getting old age pension, F.A. or maintenance allowance from any other Department of Haryana Govt. he shall be permanently debarred from getting the F.A. under this scheme run by this department.

(f) All the applications received by the Zila Sainik Boards shall be scrutinized at the level of Zila Sainik Boards itself and the applications so found for grant of F.A. shall be forwarded with full case to Rajya Sainik Board for sanction with clear recommendation of the Secretary, Zila Sainik Board.

4. sanctioned F.A. grant shall be payable to the disabled ESM from the first day of the following month in which case for grant of F.A. is sanctioned by the competent sanctioning authority of Rajya Sainik Board and no arrear for the post period prior to the date of sanction of grant of F.A. shall be paid.

5. Before the release of F.A. concerned Welfare Organizer (W.O.) shall render a written certificate on the F.A. grant roll that all the beneficiaries included in the F.A. grant roll are alive. Concerned Secretary, Zila Sainik Board will countersign the certificate given by W.O.s on the F.A. grant roll and shall be personally responsible for any lapse or error.

6. However, old eligible beneficiaries whose cases for grant of F.A. have already been sanctioned prior to issue of these guidelines shall continue to get the F.A. at enhanced rates @ Rs. 500/- P.M. w.e.f. 1.12.2004 and they need not apply afresh. However payment shall be discontinued with immediate effect to persons in civil employment.

7. Payment of F.A. to those beneficiaries shall be stopped immediately who fail to submit their survival verification proofs every year from the revenue authorities in the month of April as mentioned in para 5 above. Secretary, Zila Sainik Board shall be personally responsible for any lapse in this regards.

**DEFINITION OF  
EX-SERVICEMEN**

Definition of Ex-servicemen as adopted by Govt. of India Ministry of personnel, Public Grievances & Pensions, Deptt. of personal & Training Memo No. 36034/5 85-Estt.(SCT) dated 27.3.1987.

**DEFINITION OF EX SERVICEMEN****A. THOSE RELEASED ON OR AFTER 1.7.87**

An 'Ex serviceman' means a person, who has served in any rank whether as a combatant or non-combatant in the regular Army, Navy or Air Force of the Indian Union and

- (a) Who retired from such service after earning his pension or
- (b) Who has been released from such service on medical ground attributable to military service or circumstances beyond his control and has been awarded medical or other disability pension or
- (c) Who has been released otherwise than on his own request from such service as a result of reduction in establishment or
- (d) Who have been released from such service after completing the specific period of engagements, otherwise than at his own request or by way of dismissal or discharge on account of misconduct or inefficiency and has been even a gratuity and includes personnel of the Territorial Army of the following categories namely:-
  - (i) Pension holders for continuous embodied service.
  - (ii) Persons with disability attributable to military service and
  - (iii) Gallantry award winners.

**NOTE :** Personnel of Army postal service who are a part of regular army and are released from regular army only as per above conditions after 1.7.87 also come within the definition of ESM.

**B. THOSE RELEASES ON OR AFTER 1.7.79 BUT BEFORE 1.7.87**

An Ex-serviceman means :-

Any person who had served in any rank in the Armed Forces of the Union for a continuous period of not less than six months after attestation, if discharged for reasons other than :

(iv) At his own request or

(v) By way of dismissal or discharged on account of misconduct or inefficiency.

(vi) And not less than 5 years of service if discharged at his own request.

**C. THOSE RELEASES ON OR AFTER 1.7.68 BUT BEFORE 1.7.79**

An Ex-serviceman means :-

Any person who had served in any rank in the Armed Forces of the Union for a continuous period of not less than six months after attestation and released there from otherwise than by way of dismissal or discharged on account of misconduct or inefficiency.

**D. THOSE RELEASED BEFORE 1.7.68**

An Ex-serviceman means :-

Any person who had served in any rank in the Armed Forces of the Union and has been released there from otherwise than by way of dismissal or discharged on account of misconduct or inefficiency.

- NOTE** : (1) Personnel who have served in the Defence Security Corps. The General Reserve Engineering Force the LOK Sahayak Sena and the Para Military Forces are not Ex-servicemen within the meaning of the above definition.
- (2) In all cases Recruits are not ESM
- (3) The eligibility of the persons of the Status of Ex-servicemen will be governed by the definition in vogue at the time of his discharge and will not be affected by the changes in the definition subsequent to his discharge.
