**Subject: Revised policy/instructions regarding payment of ex-gratia grant to the member of Central Para Military Forces (CPMF) killed in operational area terrorist activities belonging to Haryana State.**

Reference is made to the office memo No. 5/19/2005-3H(C) -III dated 25.8.2014 on the subject noted above.

2. The Governor of Haryana is pleased to enhance the rate of Ex-Gratia grant to be given to the family members of the Central Para Military Forces who die in harness or are disabled in the performance of their bonafide official duties while serving in operational area in war or under terrorist/militant attack. The Governor of Haryana is further pleased to enlarge the scope of the payment of Ex-Gratia grant to include contingencies like performances of their duties during natural calamities, elections, rescue operations etc. The revised structure will be as under:-

(i)	Death in war and Action against Militants/ Terrorists etc.	Rs. 20,00,000/-	Rs. 50,00,000/-
(ii)	Death during Internal Security Duty, Operations, Election duty, Natural calamities and rescue operations etc.	Rs. 20,00,000/-	Rs. 50,00,000/-
(iii)	• Disability (75% and above) for all eligible persons.	Rs. 15,00,000/-	Rs. 35,00,000/-
	• Disability (50% to 74%) for all eligible persons.	Rs. 10,00,000/-	Rs. 25,00,000/-
	• Disability (25% to 49% to 74%) for all eligible persons.	Rs. 5,00,000/-	Rs. 15,00,000/-

3. The enhanced amount is applicable to the casualties which occurred on or after 1.11.2016 only and who are residents of Haryana at the time of joining the service.

4. The grant of Ex-Gratia prior to issue of this policy will be given as per policy No.5/19/2005-2HC dated 4.1.2006.

5. All other conditions as contained in office memo No.5/19/2005-2HC dated 4.1.2006 regarding of Ex-gratia shall remain unchanged.

6. The expenditure will be met from the scheme code-N -51-22.2235-60.200-77-51(Object Head(09))- Grant in aid.

7. This issue with the concurrence of Finance Department conveyed vide their U.O No. 1/54/2005-5 F.G.-II(35852)/37677(FMIS) dated 13.12.2016.
