2. As per announcement made by the Hon'ble Chief Minister during 'Veer Naris' meet at Meham on 4-10-2008 it has been decided that the present rate of financial assistance for the marriage of the daughters of widows of Ex-servicemen (other than war widow) has been increased from Rs. 5,100/- to Rs. 11,000/- w.e.f. 4th Oct. 2008. It is, however, clarified that proforma of applications and instructions already issued for marriage grant will remain the same.

Subject:- Grant of financial aid to widows of Ex-servicemen for the marriage of their daughters.

You are hereby informed that for some time past the matter regarding grant of financial assistance to the widows of ex-servicemen (other than war widows) for the marriage of their daughters had been engaging the attention of Haryana Government in general and Rajya Sainik Board in particular. It has now been decided to give financial assistance of Rs. 1000/- to the widows of ex-servicemen as and when their daughter's marriage is solemnized. It has also been decided that the entire verification of claimants will be carried out at the level of the Secretaries of Zila Sainik Boards as hither-to-fore. The marriage grant will be admissible to the widows out of Haryana Defence and Security Relief Fund subject to the following conditions :-

- (i) The widows had not remarried. If remarried, she should not have been remarried other than the real brother of her late husband.
 - (ii) She should be the resident of Haryana State.
3. A Performa for grant of financial assistance to the widow (other than war widows) is enclosed for favour of necessary action.
