
Subject:- Guidelines for Hiring of Taxis for the officers visiting New Delhi for official work.

Sir/Madam,

I am directed to refer to the Haryana government letter No. 3/71/2008-RVA dated 27.07.2017 on the subject noted above wherein you were informed that Haryana Government has signed the contract with M/s Ajay Tours, UG-16/17, Palika Place Panchkuian Road, New Delhi for the period 01.08.2017 to 31.07.2018 through PRC, New Delhi. The approved rates of M/s Ajay Tours are enclosed herewith.

2. With the implementation of this policy, the officers visiting Delhi by train or by Air are advised to use the facility of taxi to be made available on their request for the efficient and effective implementation of the policy, the guidelines are as under:-

- (i) The officer requisitioning taxi service at New Delhi will inform PRC Office at least one day before departure through Tel. No. 011-23386131 or by Fax No. 011-23334913. The Contact No. Superintendent is 011-23385980, 9717440212 and RA is 9818672439.
- (ii) On the same day the Superintendent/RA concerned will inform the officer taxi no./ Modal of Taxi, Driver name and his mobile No.
- (iii) The officer will also inform his mobile No. so that the taxi driver and the officer may not face any difficulty regarding identification of each other.
- (iv) **The policy will work as under:-**
 - (a) The officer after performing the local journey and before relieving the taxi will sign the contents of log slip indicating K.Ms covered and time consumed.
 - (b) The taxi agency will send the bill to the Principal Resident Commissioner office within a week and immediately thereafter PRC office will send the same to the concerned department. On the receipt of the bill, the department will make the payment to PRC Office within next three days.
