**Sub: LPA No. 1509 of 2010 in CWP No. 53 of 2009- Baljeet Singh &
ors. Vs. State of Haryana and other LPAs.**

Reference Government memo No. 42/20/2009-5GSI dated
20.1.2011 on the subject noted above.

2. The appellants in these LPAs have raised the issue that the affidavit dated 14.12.2009 indicating the details of 145 vacancies of clerks during the period from 15.09.1989 to 18.11.1995 which were existing as on 07.12.1998 is not correct due to the fact that the appellants have secured information of vacancy position between the abovesaid period under the RTI Act from 12 Departments and as per which the vacancy position comes to 299. The Hon'ble High Court has directed to explain the discrepancy through filing an affidavit.

3. In view of the Hon'ble High Court direction, the concerned departments were requested vide Government Memo No. 42/20/2009-5GS-I dated 20-01-2011 to send the factual vacancy position in this regard. After repeated requests the information received did not tally. The complete relevant record was sought and examined by General Administration Department. This exercise took a lot of precious time i.e. about one month of the Government to locate the reasons for discrepancy.

4. After having the matter examined threadbare, it is observed that your department had given wrong information under the RTI Act which is not only violative of the RTI provisions but reflects serious negligence, callousness and irresponsiveness on the part of the concerned officers/ officials in dealing with such a serious and sensitive issue.

5. It is, therefore, requested to get the matter probed and fix the responsibility to take appropriate action against the erring officers/ officials under the provisions of RTI Act for providing wrong information, under Government Employees Conduct Rules, 1966 and also calculate the expenditure incurred by way of TA/DA, fuel charges of the vehicles and time taken in this exercise and recover the same from the concerned within a period of one month positively and send the compliance report.
