OFFICE MEMORANDUM

Subject:- Singapore – Norway TCTP Seminar on Sustainable Use of Water Resources 30 June – 2 July, 2010.

1. Singapore High Commission has offered the above-mentioned Seminar to be held in Singapore during 30 June – 2 July, 2010 under Singapore-Norway Third Country Training Programme(TCTP).
2. The applicants should be senior management (policymakers) with at least 5 years relevant experience in water management, nominated by their respective governments and should be below 50 years of age.
3. The Government of Singapore and the Kingdom of Norway will bear the following expenses during the Seminar in Singapore:
- (a) An economy class, round-trip, air ticket between the respective international airports designated by the Ministry of Foreign Affairs, Singapore.
 - (b) A daily training allowance of Thirty Singapore Dollars(S\$ 30) to be given to cover for meals and daily expenses from the first day to last day of the seminar.. Complimentary breakfast is provided in the hotel from first day to one day after the Seminar.
 - (c) Transportation to course venue and site visits;
 - (d) Training fees, including lecture fees, administrative fees, and teaching materials;
 - (e) Medical insurance for participants to cover accident and hospital treatment during their stay in Singapore in accordance with the policy of a local insurance company.
 - (f) Accommodation for the entire duration of the course.
4. Each participant is advised to have money for miscellaneous expenses that might be incurred prior to receiving the allowance.
5. The number of nominations to be sent to this Department may not exceed two.
6. The nominations of suitable candidates may be done in accordance with the Department of Economic Affairs' OM No.1/13/03-PMU dated 27.2.2006. The nomination details should be submitted on the following:
- 1. Prescribed application form
 - 2. DEA's prescribed proforma – duly countersigned by competent authority.
7. Last date for submission: The completed 'application form' should reach this Department not later than 4.5.2010. Nominations received after the prescribed date will not be considered.
