Dear Ma'am,

As you are aware, under the existing scheme of in-service training programmes for IAS Officers, all eligible IAS Officers are expected to attend a 1-week in-service training programme, once in a block of two years. Under the current block of year 2010-2012, the year 2010-2011 is the first year of this block which is commencing from April, 2010. It may also kindly be noted that the 2-week training programmes have been replaced by the Mid-Career Training (MCT) programmes for IAS Officers, which they are required to attend at specified stages of their career.

2. The IAS Officers from 1980 to 2000 batches are eligible to attend the one-week in-service training programme this year. Officers at the levels of Deputy Secretary / Director / Joint Secretary in the Central Ministries/Departments, who are posted under the Central Staffing Scheme, are also eligible to attend a one-week training programme.

3. I enclose herewith the calendar of the one-week in-service training programmes available for the year 2010-2011 (Annexure-I). I request that the calendar may kindly be circulated among the eligible IAS Officers in your State.

4. It is also requested that the officers may be encouraged to opt for those training programmes which are relevant to their current jobs as well as the kind of assignments they are likely to hold in future.

5. While nominating these officers in the training programmes, the complete address with ID Number of the Officer, telephone number, fax number and e-mail address must be given. The list of nominated officers may kindly be sent to this Department or to Shri P.K. Subnani, Joint Director (Training), E-mail ID: subnani.pk@nic.in well in advance before the commencement of the training programme.

6. I solicit your kind cooperation for the successful conduct of the training programmes, by enabling wide publicity of the programmes amongst the IAS Officers and by facilitating the attendance of a large number of officers in these programmes.

7. Besides the above training programmes, Lal Bahadur Shastri National Academy of Administration (LBSNAA) - Mussoorie, Sardar Valabh Bhai Patel National Police Academy (SVPNPA) - Hyderabad and Indira Gandhi National Forest Academy (IGNFA) – Dehradun will be conducting Joint Training for IAS, IPS and IFS Officers on various themes during the year 2010-2011. The series of joint courses to be conducted by these National Academies is enclosed (**Annexure-II**).

8. Kindly nominate a composite team of officers consisting of one each from IAS, IPS and IFS who are preferable serving as District Magistrate/Superintendent of Police/district Forest Officer in the field or those who have recently served in the field or are of an equivalent level, for each of the joint courses to be conducted by these National Academies.

9. The nomination of the officers, with full contact details such as name, designation, address, telephone number, fax number and email address may be sent directly to the Director of the concerned Academy.
