# Capacity Building Programme for Urban Development

Date: 2nd to 4th February 2022

Duration: 3 Days (online)

# Course Description

India is urbanising quickly, yet, the realisation that managing urbanisation is critical to both India's growth as well as equity agendas has only recently begun to fully sink in. The fact is: whether India manages to achieve sustainable, inclusive growth in the coming decades is contingent on whether it is able to benefit from and direct its urbanisation. The numbers speak for themselves. India's urban population will rise to 600mn by 2031, that's nearly 200mn more urban residents in the next decade. Possibly 30-50 percent of these will be poor at the same time that 60% of the GDP will come from cities. This is the second largest urban transition in history - one that represents both an astonishing opportunity and a significant challenge.

Buzzwords are all around us: "Smart Cities," "Sustainable Cities," "Inclusive Cities". Which one of these should Indian cities aspire to be? Just as importantly: how do cities get there with their current challenges of struggling infrastructures, social and economic inequality, and fragmented governance? Especially when India is a signatory to the UN's Sustainable Development Goals (SDGs). Particular focus would be on SDG 11: Sustainable Cities.

These are some of the complex sets of questions facing Indian cities today. Some are part of everyday public debate and others are matters of specific technical complexity. For example: should a city build a metro system or a bus rapid transit, or expand? How are consumption needs and patterns changing? Where should city managers invest - can, for example, the Bangalore city-region continue to rely on IT as a key growth sector? Should a city's Master Plan regulate its land and housing markets - can it? How will new proposed urban corridors shape the individual city-regions? In the post Covid world, what direction should urban development take?

Answers to complex sets of problems presented by Indian cities are not likely to be found within narrow constraints of particular professions and knowledge domains. It requires a new kind of professional who can engage and innovate across sectors and disciplines.

The proposed course represents an opportunity to do precisely this. Tackling the broad theme of urban development, it would provide officers with the training to professionally engage with and work in the urban landscape. Bringing complex, real-world problems of urban India into the classroom through case-led teaching and learning, the course will leverage the expertise and experience of working practitioners and enable them to apply it to a new domain.

# **Expected Skill Development**

The programme will lead to the building of these skills:

- 1. Appreciate inter-connections between the complex systems that constitute the Urban
- 2. Provoke an emotion/experience/reaction leading to personal insights and locate their own practice in a deeper understanding of economies, markets and environmental concerns in contemporary urban India
- 3. Enhance propositive capacity
- 4. Develop decision-making ability especially in the urban context

This programme aims to prepare the officers to professionally engage with the complex environment of urban development and build their ability to practice in it.

## **Key Learning Outcomes of the Programme**

- Be exposed to perspectives on urbanisation and regional development in India, with a focus on practice terrains such as urban governance, policy, planning, land management, services provision and economic development
- Contextualise urban and regional development issues and interventions in relation to actual practices of governance, social and political relations, and economic transitions
- Be introduced to urban sectors (water and sanitation, energy, housing, etc.) and how they function
- 4. Locate their own practice in a deeper understanding of economies, markets and environmental concerns in contemporary urban India
- 5. Understand key emerging trends from climate change to new urban forms like corridors within the urbanisation story in India
- 6. Be exposed to key visual and quantitative methods in urban practice

# **Programme Design and Pedagogy**

#### Theory of Change

Changes in urban design and morphology of the urban built environment often involve several stakeholders, and in the case of urban development this can be very slow and laborious. Therefore, we propose a Theory of Change approach to this programme that is based on the idea that long term systemic changes can be achieved through a series of interlinked short and mid-term engagement pathways. Since engagement pathways are nested within each other, a series of strategic and focused short term interventions can lead to big changes in the long run. Our Theory of Change approach will include engagement with multiple stakeholders through case based learning that will focus on the importance of leadership in bringing about sustainable change.

## Instructional Design Strategy

Case-based and site-based learning are central to IIHS's pedagogy, enabling working backwards from wicked problems. The focus is on developing problem-solving skills, as well as building capacity to formulate innovative and sustainable solutions. IIHS has taken on the task of preparing a portfolio of cases for teaching and training. These cases have been developed through multiple grants from organisations such as the Ford Foundation and the Rockefeller Foundation, and address contemporary urban conditions in India. Faculty will draw upon these cases in this online training programme. The module design, content and learning objectives will be developed using IIHS's experience in capacity building in the urban space and our expertise in designing online learning modules. The course will be designed keeping in mind the following capacity building framework.

The programme will be developed and run as a mix of online synchronous modules hosted on IIHS' Learning Management System (LMS). The following modules are being proposed for the Capacity Building Programme on Urban Development:

- · A Perspective on the Urban India Story
- Urban Sanitation
- Water supply
- · Urban Mobility and Transportation Planning
- · Approaching "Housing for All"
- Urban Livelihoods
- Solid Waste Management
- · Issues in Urban Land Governance-I
- · Issues in Urban Land Governance-II
- · Panel Discussion

The diverse set of topics proposed are aimed at providing learners with a holistic picture of urban development in India and provide detailed insights on actual on-ground-practices and also locate their own practices with a deeper understanding. A range of pedagogic approaches will be used to enable better understanding and learning. These would include: interactive sessions for perspective building and thematic understanding; skill based sessions, and master classes with IIHS Board Members and/or Senior Advisers. The synchronous sessions will be hosted on a suitable learning platform facilitating peer-to-peer learning and faculty-participant engagement. These sessions will be highly interactive with the use of learner engagement tools such as online group activities using breakout rooms, in-class polls and quizzes, mentimeter, padlet, etc. Aside from the presentations, video content and references to be uploaded, asynchronous learning materials will be custom designed and hosted on the LMS platform which provides a range of features for interactivity including surveys, polls, discussion forums, casual chat rooms for participants, assignments, wikis and glossaries, which can be co-created by learners and facilitators together and other interactive learning applications. The progress of learners can also be mapped to skill levels and Points, Badges, Certificates and Transcripts can be awarded against course-activities, courses, and programmes to boost learner engagements.

# **Key Programme Differentiators**

IIHS is a unique institute in the field of capacity building in India. The six key differentiators of IIHS UPP course from other courses are the interdisciplinary framework of teaching and training, and the ability of IIHS' faculty to bridge practice with research.

Interdisciplinary Framework for Training: The IIHS approach to training and teaching around urban development is unique as it is fundamentally rooted in interdisciplinarity. IIHS creates and delivers content in the core belief that issues around India's human settlements can only be addressed through an integrated and holistic approach which covers all the four layers of human settlements – social, economic, legal and physical. In addition, environmental sustainability is an overarching principle of IIHS research, teaching and practice.

Bridging Research and Practice: IIHS faculty are researchers and practitioners, and use the insights from their fields of work to deliver training and teaching programmes. Through this approach, IIHS faculty are able to effectively translate learning from their practice experience to teaching and training content that satisfies the learning needs of participants more successfully than only theoretical concepts. This teaching method allows for greater reflexive capacity within the participant. Yet at the same time, since IIHS faculty are involved in research around urban development, they are able to co-create conceptual ideas with participants leading to a richer learning experience.

Interactive Sessions: Approximately half of the programme will consist of lectures and interactions with participants led by IIHS faculty. Many of such sessions will be team-taught, that is, multiple faculty will engage with the participants in class such that they are able to get a richer and more diverse understanding of the conceptual issues at hand in a single session.

Case based teaching: With the objective of developing competencies in the urban, a particular focus will be given to using the case-based learning approach. The cases used in the programme will span across various sectors and will allow learners to apply general principles in actual contexts and learn them not just in abstraction but in actual application. This will build their competency, lead to better knowledge retention and provide participants at all levels an agency in their own learning journey.

Master Classes: The participants will have the opportunity to meet thought-leaders and practitioners from India and across the world, to learn about their work and challenges they face as practitioners in different disciplines and domains of urban practice. The Master Classes will provide a platform to discuss the ethical, political, and material complexities of practicing in Indian cities.

Online learning: IIHS is equipped with instructional designers and digital learning experts, who have immense experience in designing online courses for urban practitioners. The content and design for our online courses considers the cognitive capacity of the learners to ensure long term retention and in-depth understanding of the course material. Further, through the support of our DBL programme the following objectives of online learning are achieved:

- Enrich the experience of learners and participants of various IIHS courses by supplementing classroom sessions with rich multimedia content, both in-class and before and after the class.
- Take the conversations and debates on urban practice, science and studies to a wide audience
  of academics, students, and practitioners across India and the world, through a combination of
  standalone MOOCs and blended learning programs.
- Create a rich repository of digital learning assets on urban practice, science and studies, for teachers, learners and researchers.
- Provide learning content from experts in India and from across the world, in multiple languages.
- Enable strong peer-to-peer learning experiences and collaborative problem-solving opportunities around some of the most pressing urban challenges of our age.

The following general guidelines/instructions/information with regard to One-Week In-Service Training Programmes (Offline/Physical) and 3-5 day Online In-Service Training Programme for the year 2021-22 for AIS (IAS, IPS & IFoS) Officers, Officers working under the Central Staffing Scheme and Central Secretariat Service (CSS) and Central Secretariat Stenographers Service (CSSS) Officers (of the level of DS/Sr. PPS and above)

# 1. Eligibility:

- (a) AIS (IAS, IPS & IFoS) Officers:
- (b) Officers working under the Central Staffing Scheme in the Government of India with minimum of 4 years of Service up-to the rank of Secretary to the Govt. of India and Chief Secretary in the State Govt. and equivalent;
- (c) Central Secretariat Service (CSS) and Central Secretariat Stenographers Service (CSSS) Officers of the level DS/ Sr. PPS and above.
- 2. All the training programmes (Offline/Physical Mode) are residential in nature. Accommodation facilities will be provided to the participants by the training institutes who are organizing the training programme.
- 3. The 3-5-day Online Training Programmes are attended through virtual mode. These programmes are not residential programmes.
- 4. The IAS officers are required to apply on-line through the Intra IAS portal. All other Officers are required to apply through the prescribed proforma available with these guidelines after obtaining approval of the Competent Authority of the Department/ Ministry/ State Government/ Cadre controlling authority concerned.
- 5. The Officers who are due for retirement may not be sponsored for the training programme scheduled in the month in which they are due to retire.
- 6. The Officers posted abroad are exempted from participation in the programme and their applications will not be considered.
- The Officers are not allowed to apply or change options within 10 days of the commencement of an opted programme.
- 8. The Officers can attend only one In-Service Training Programme either Physically OR online during the financial year 2021-22.
- The minimum no. of participants may not be less than 15 and the maximum no. may not exceed 40 to ensure economic viability and optimal utilization of training programs for better career prospects.
