Sir/Madam,

I am directed to refer to the subject mentioned above and to say that keeping due to the prevailing drought conditions in view of the deficit rain fall, it has been decided to earmark each of districts to an Administrative Secretary for close monitoring of the situation including availability of drinking water, power supply, canal water for irrigation, food grains and other essential commodities, kerosene oil/cooking gas, fodder etc.

2. The Administrative Secretary so earmarked may immediately visit the concerned district and critically review the situation on an emergent basis. He/she must coordinate with various departments/agencies to ensure timely and adequate relief to the affected people and keep the Chief Secretary and Financial Commissioner, Revenue informed of the situation prevailing in the district and also bring to the notice of Administrative Secretary of the concerned Department any matter/ issue which requires immediate intervention at the State level.
