The Governor of Haryana is pleased to order that Shri A.K.Singh, IAS(HY:91), Principal Secretary to Government, Haryana, Personnel, Training, Vigilance and Parliamentary Affairs Department, Director General Training(Ex-officio) and Inquiry Officer, Vigilance, Haryana shall also function as Special Officer for Rohtak, Jhajjar and Sonapat Districts for the purpose of restoring peace and order in these districts.
