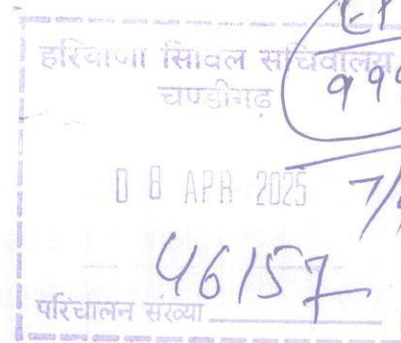

(A) (i) holding analogous posts on regular basis in the parent cadre/department;

or

(ii) with two years service in the grade rendered after appointment thereto on a regular basis in posts in Pay Band 2 Rs. 9300-34800 plus Grade of Rs 4600 or equivalent in the parent cadre or department; and

(B) Possessing the following educational qualifications and experience:

(i) Bachelor's Degree from a recognized University/Institute;

(ii) 3 years experience in administration or establishment or accounts in a Government office.

Note: 1 The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation.

Similarly deputationist shall not be eligible for consideration for appointment by promotion.

Note:2 Period of deputation including period of deputation in other ex-cadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Govt. shall ordinarily not to exceed 3 years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.

It is requested to circulate the vacancy and forward the application of the official who fulfils the eligibility criteria & willing to join on deputation for a period of one year or his/her services are required by the Health Department, UT, Chandigarh till said posts are filled up on regular basis by promotion from the eligible candidates in the feeder cadre whichever as earlier along with last 05 years ACRs Dossier, Vigilance Clearance Report, No Departmental Inquiry/Complaint & Integrity certificate, mandatory ICT Skill Certificate as per DOPT guidelines **within a period of 30 days from the date of issue of this letter** for taking further course of action in the matter. Application received after the last date or without the ACRs Dossier or otherwise found incomplete will not be considered.
