

Sir,

The Phase-III of the Mid-Career Training Programme (MCTP) for IAS officers is scheduled to be conducted at the Lal Bahadur Shastri National Academy of Administration, Mussoorie from 12th May to 6th June, 2025.

The objective of the Phase-III programme is to develop 'next-level competencies' among officers. The course aims to expose participants to best practices in governance and service delivery through experience sharing and case studies, and to equip them with tools and techniques necessary for effective implementation of development schemes and projects.

It is pertinent to mention that successful completion of Phase-III Training is a mandatory prerequisite for appointment to the Junior Administrative Grade (JAG). However, out of a total of 1225 eligible officers, 586 officers from 2010 to 2014 batches have not attended this course. Timely nomination and clearance by the respective cadre authorities is requested to enable confirmation of participation. Officers may be advised to report at LBSNAA, Mussoorie by 11th May, 2025 (Sunday) for the training programme.
