I am directed to invite your attention to the letter of even number dated 15.11.2022 & reminder dated 19.12.2022 and 02.01.2023 vide which all the Administrative Secretaries/ Heads of Departments/ Divisional Commissioner/ Deputy Commissioner were requested to provide the information in connection with employees who have been dismissed/ removed/ prematurely retirement from service at age 50/55 years or after completion of twenty years' qualifying service in last 20 years in the prescribed proforma.
