Subject:- Haryana Government Employees New Group Insurance Scheme, 1985- Table of benefits for the savings fund for the period from 01-04-2025 to 31-03-2026.

Sir/Madam,

I am directed to invite your attention to Haryana Government letter of even number dated 30-09-2025, on the subject noted above and to forward herewith the Tables of Benefits for Savings Fund to the beneficiaries under the New Group Insurance Scheme, 1985, which are being issued on a quarterly basis from 01-04-2017 onwards, as based on GOI's Letter No.7(2)/EV/2016 dated 17-03-2017, for the quarter from 01-01-2026 to 31-03-2026, as worked out on the interest rate of 7.1% p.a. (compounded quarterly) based on GOI's letter No. 7(1)/EV/2023 dated 22-11-2025, are enclosed.

2. The Tables enclosed are of two categories as per the existing practice. As hitherto, the first Table of Benefits for the savings fund of the scheme is based on the subscription of per unit of Rs.10/- per month from 01-04-1986 to 31-12-1989 and per unit Rs.15/- per month w.e.f. 01-01-1990 onwards. The second Table of Benefits for the savings fund of the scheme is based on the subscription of per unit of Rs.10/- per month for those employees who had opted out of the revised rate of subscription w.e.f. 01-01-1990. The mortality rate under the scheme has been taken as 3.75 per thousand per annum upto 31-12-87 and 3.60 per thousand per annum thereafter in both cases. While calculating the amount, it has been assumed that the subscription has been recovered or will be recovered from the salary of the month in which a member ceases to be in service failing which it should be deducted from accumulated amounts payable.

While these orders are in respect of Tables of benefits for the period from 01-01-2026 to 31-03-2026, the Tables, which has already been issued for the first, second and third quarter i.e. for the period 01-04-2025 to 31-12-2025 are also attached for the sake of convenience and consolidation.
