2. (i) Degree in Law (L.L.B.) from recognized University or equivalent;
- (ii) Twelve years' experience in a state judicial service out of which five years should be at the level of Additional District Judge and Session Judge or above. Or

Twelve years' practical experience at the bar out of which five years should be in a High Court as a Senior Advocate; or

Note1; Qualification(s) regarding experience is/are relaxable at the discretion of the Union Public Service Commission in case of candidates otherwise well qualified.

Note2: The qualification (s) regarding experience is/are relaxable at the discretion of the Union Public Service Commission in the case of candidates belonging to Scheduled Castes or Scheduled Tribes, if at any stage of selection the Union Public Service Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the posts reserved from them.

- (ii) Doctorate Degree in Law from a recognized University or equivalent

4. **Regulation of Pay and other terms of deputation:** The pay of the selection candidate will be regulated under the provision contained in the DoPT O.M. No. 6/8/2009-Estt.(Pay-II) dated 17.06.2010 as amended time to time.

5. **Age Limit:** - The maximum age limit for appointment by deputation (including short-term contract) or absorption shall be not exceeding 56 years as on the closing date of the receipt of applications.

The Period of deputation/contract including period of deputation or contract in another cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed four years.

It is, requested to circulate the vacancies and forward the application of the officers who are willing and fulfill the eligibility criteria and who can be spared immediately in the event of their selection to the undersigned, complete in all respects along with following documents may be sent to this office within 45 days from the date of publication in the **Employment Newspaper**.

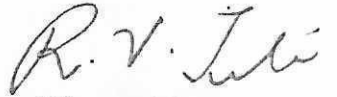
