Sub:- Selection for the post of Chairman in the Haryana Electricity Regulatory Commission – Invitation for applications – Regarding.

The Haryana Electricity Regulatory Commission (HERC) was constituted in 1998 with a Chairman and two Members under the Haryana Electricity Reforms Act, 1997 to regulate the Electricity Industry in the State. The post of the Chairman has fallen vacant in HERC on 18.10.2020. The qualifications for appointment of Chairman of State Commission and his terms of office and conditions of service are provided in Section 84 and 89 of the Electricity Act, 2003, respectively. The pay and allowances of Chairperson of the State Commission have been provided in Rule-3 of the Haryana Electricity Regulatory Commission (Conditions of service of Chairman and Members) Rules, 1998 as amended from time to time. An extract of Section 84, 89 of the Electricity Act, 2003 and Section-3 of the aforementioned rules is enclosed, for ready reference.

2. As per Section 84 of the Electricity Act 2003, the Chairperson of the State Commission shall be person of ability, integrity and standing who has adequate knowledge of and has shown capacity in, dealing with problems relating to engineering, finance, commerce, economics, law or management. The Chairperson of the State Commission shall not hold any other office as provided in sub-section (3) of Section 84 of the Electricity Act, 2003.
3. The Chairperson shall hold office for a term of five years from the date he enters upon his office provided that no Chairperson shall hold office as such after he has attained the age of sixty five years, as provided in Section 89 of the Act.
4. As per Rule 3 of the Haryana Electricity Regulatory Commission (Conditions of service of Chairman and Members) Rules 1998 as amended from time to time, the Chairman shall receive a pay in the apex scale of Rs. 2,25,000/- (Fixed) per month in the pay matrix level 17 (corresponding to the pay scale of Rs. 80,000/-). However, the pay of the Chairman shall be subject to deduction of the gross amount of pension including any commuted portion thereof if already getting.
5. The last date of receipt of applications, both by post/e-mail, is 21 days from the date of issue of this letter i.e. **16.11.2020 by 05.00 PM**. The address for correspondence is:-

6. Eligible persons interested for this post may also apply direct alongwith bio data giving full details of educational qualifications and professional experience so as to reach above given address before the due date with the following information:-


A) The bio-data of the proposed candidate should include the following details alongwith his/her signature and date:

- i) Name
- ii) Age & Date of Birth
- iii) Position now held
- iv) Educational Qualification
- vi) Details of posts previously held and experience in any of the field of engineering, finance, commerce, economics, law or management.

B) The communication should contain a letter from the person proposed intimating the details of any office, employment or consultancy agreement or arrangement which he/she has in his/her own name or in any firm, association or persons or body corporate, or in the names of any relative, carrying on any of the following business, namely:-

- i) Generation, transmission, distribution or supply of electricity.
- ii) Manufacture, sale or supply of any fuel for generation of electricity.

- iii) Manufacture, sale, lease, hire or otherwise, supply or dealing in machinery, plant, equivalent, apparatus or fittings for the generation, transmission, distribution, supply or use of electricity and
 - iv) Any entity providing professional services or any of the business referred to in sub-clause (i), (ii) and (iii) above.
- C) In addition to the above data, proposal should also include a letter of willingness to resign his/her post and to join as Chairman, HERC if selected.
- D) A declaration in the form of undertaking is also required to be submitted along with the application on the following points:
- i) That he/ she does not have any financial or other interest which is likely to affect prejudicially his/ her function as Chairman, Haryana Electricity Regulatory Commission.
 - ii) Whether any criminal case has been registered against applicant?
 - iii) Whether applicant has been charge-sheeted for any criminal offence? If yes, the details thereof.
 - iv) Whether applicant has been convicted by any competent court for any criminal offence? If yes, the details thereof.
- E) In addition to the above, the application should also include the following information/ documents:-
- i. To furnish experience certificate in their respective field from their employer/ex-employer or from the organization with which they are/were associated with. The persons who are self-employed can submit self-certificate mentioning their nature of field & experience.
 - ii. Those who are working in Government or PSUs be asked to submit the ACR of the last five years and integrity certificate from their organization.
 - iii. Candidates who have retired from Government or PSUs be asked to submit ACR record of last five years of their service and integrity certificate from the organization from which they have superannuated.
