Subject:- Updation of progress of the Haryana Statute Review Committee under the Chairmanship of Mr. Justice Iqbal Singh (Retd.), Commissioner, Gurudwara Election Commission.

Sir,

Kindly refer to this office letter of even number dated 15th July, 2016 and subsequent reminder dated 11th August, 2016 and dated 23rd August, 2016 on the subject noted above.

2. The Haryana Statute Review Committee constituted by the State Government to identify such laws which are not in harmony with the existing climate of economic liberalization and need change, and to identify laws which otherwise require changes or amendments, and to make suggestions therein and related matters. The Committee has submitted its First Report in June, 2016. In its Report, the Committee has recommended repeal of 56 Acts (Departmentwise list enclosed).

3. Government decided that as per recommendations of Haryana Statute Review Committee, respective Administrative Departments will examine the recommendations in respect of repeal of the Acts on file for consideration of Hon'ble Chief Minister by 31.7.2016 and the draft repealing Acts be brought in the next Assembly Session positively. But no report has been received till date.

4. You are again requested to send your report immediately to this department so that Hon'ble Chief Minister could be apprised. It is also requested that an interim report in following proforma may also be sent to this department within 15 days positively:-
