Dear Madam,

As you are aware that the Haryana Staff Selection Commission has recommended 4591 names for appointment as Clerk in various departments. As per State Training Policy all the new entrants in Haryana Govt. service are to be imparted one month induction training. HIPA has obtained the departmentwise list of the number of clerks recommended by HSSC and has designed the induction training programme for the said category. Since the number of trainees is very large and class room trainings are not feasible due to the spread of COVID-19 pandemic, in the first phase, HIPA has planned one week virtual induction training for all the clerks. The training will be conduced from six places four DTCs, HIPA and two more centres from H.O. HIPA Gurugram. Each center will run training for two batches, each of 50 candidates, simultaneously. Thus, in 90 batches the training for all the 4591 trainees will be completed in 8weeks time. Further trainings will be planned and conducted taking into account the pandemic conditions. Divisional Training Centre (HIPA), Panchkula (dtcpanchkula@gmail.com) will coordinate the training with other training centres and the departments for the purpose. The detailed training schedule is enclosed.

I therefore, request you to kindly direct all HODs to issue necessary directions in their respective department and ensure the joining of newly appointed clerks on virtual Training programme as per the schedule provided by HIPA. They may also be directed to pay virtual training fee @ Rs.500/- per participants per day to HIPA.
