Subject : ALAF Integrated management of international rivers in response to climate change.

Monash University has offered the above mentioned programme to be held in Monash University, Australia during 3 to 4 weeks from November 15, 2010.

2. The fellowship programme will develop a collaborative approach harnessing the collective capacity of the participating institutions.
3. The selected participants will be provided a return economy class travel, a per diem allowance (while Melbourne) of 280 to cover accommodation, meals, and incidentals, training costs (for Monash university).
4. The number of nominations to be sent to this Department may not exceed Six.
5. The nominations of suitable candidates may be done in accordance with the Department of Economic Affairs' OM No.1/13/03-PMU dated 27.2.2006. The nomination details should be submitted on the following:
