TRAINING CIRCULAR

Subject: A Group Training Course in Construction Technology Introduced  
and/or Applied to Developing Countries to be held in Japan from 8<sup>th</sup>  
May 2011 to 25<sup>th</sup> June 2011.

The undersigned is directed to state that the Japan International Cooperation Agency (JICA), under the Technical Cooperation Programme of the Government of Japan has invited applications for the above programme, to be held in Japan from 8<sup>th</sup> May 2011 to 25<sup>th</sup> June 2011. The details of the programme and the application form may be drawn from Ministry of Personnel, Public Grievances and Pensions website (persmin.nic.in).

2. The Program aims to contribute to improve the civil engineering in their respective countries and motivate the participants to work on the establishment of their own technical standard and system.

3. The Candidate should be mid-career officials or researchers who are in charge of civil engineering(except building or housing works); have between 8 and 18 years of occupational experience in construction work; be a graduate of university or equivalent in the field of civil engineering; be proficient in written and spoken English; be in good health, both physically and mentally to undergo the above training; and not be serving in any form of military service

4. The course covers the cost of a round-trip air ticket between an international airport designated by the JICA and Japan will be borne by JICA; travel insurance from the time of arrival in Japan to departure from Japan; allowances for (accommodation, living expenses, outfit and shipping); expenses for JICA study tours and free medical care for participants who may fall ill after reaching Japan (costs related to pre-existing illness, pregnancy, or dental treatment is not included). The participants are not allowed to take any family member during the training course.

5. It is requested that the nomination of the suitable candidates may please be forwarded to this Department in accordance with the eligibility criteria and the terms and conditions of the JICA's Circular dated 2<sup>nd</sup> February 2011. The Ministry/State Governments may sponsor the names of only Government/ Public Sector Undertaking functionary.

6. The nomination details should be submitted in the JICA's prescribed proformas (A2A3 Forms) duly authenticated by the Department concerned alongwith the country report.
