Subject: Recruitment of Group 'D' category Employees in the State.

My Dear Administrative Secretary,

Please refer to my earlier D.O. No. 42/21-A/2008-5 GS-I, dated 4th February, 2009, on the subject noted above.

- 2. In order to ensure uniformity in qualification and speedy recruitment of posts of Group 'D' category employees, the State Government vide its letter No. 42/116/2009-5GS-I, dated 4th June, 2009 (copy enclosed) has made amendment in Service Rules of Group 'D' employees of Departments of the State Government and Boards and Corporations of the State Government. In this letter, it was requested to make amendment in the Service Rules within two weeks positively under intimation to the Government. The compliance of this letter has not been reported as yet.
- 3. Letters for seeking the requisitions of vacant posts of Group 'D' were also sent to all concerned by the Secretary to Haryana Group 'D' Employees Selection Committee, vide letter No. 1/1/HGDESC/2009, dated 21.1.2009, followed by reminders of even number dated 3rd February, 2009, 13th March, 2009 and 18th May, 2009. However, the requisition from your Department has not been received in the office of the Committee.
- 4. I would, therefore, again request you to look into the matter personally and ensure submission of requisition of the Department to the Committee within a week positively.

Subject:- Amendment in Service Rule of Group 'D' Employees of Departments of the State Government.

Sir/Madam.

am directed to refer to the subject noted above and to say that it has been observed that different academic qualifications for the posts of Peon, Chowkidar and Peoncum-Chowkidar have been prescribed by various Government departments. Some Departments have prescribed knowledge of Hindi & English. Yet there are some departments which have prescribed Middle as a minimum educational qualification for these posts.

- The Government has considered the matter and it has been decided to bring 2 about uniformity in respect of qualifications for the such posts in all the departments. Further, it has been decided to prescribe 'Middle pass with Hindi' as educational qualification for the posts of Peon, Chowkidar and Peon-cum-Chowkidar.
- The concurrence/approval of Finance Department, Legal Remembrancer and Council of Ministers has been obtained in the matter. It has been decided that it will also serve as model amendment for all departments of Haryana Government and they would amend their Service Rules accordingly without sending the proposal to Council of Ministers, General Administration, Finance Department and Legal Remembrancer for approval.
- You are, therefore, requested to amend relevant Service Rules accordingly within a period of two weeks positively under intimation to the Government. A copy of Service Rules after amendment may also be provided to the General Administration.
- 5. These instructions may please be brought to the notice of all concerned for information and necessary action.
